

Notes of Interest from the City Across the Delaware.

The stockholders of the new Camden National Bank held another meeting yesterday and elected the following Board of Directors: Henry B. Anthony, Dr. George W. Bailey, Irvin O. Beatty, Howard M. Cooper, John Cooper, James Davis, Herbert O. Felton, Philip H. Fowler, George P. Halnes, Zophar O. Howell, Zophar L. Howell, Rudolph W. Birdsell, William B. Mulford, Charles E. Thomas, Isaac O. Toom, Henry B. Wilson, Charles B. Coles. Zophar O. Howell was chosen president; John Cooper, vice president; Howard M. Cooper, solicitor, and Isaac O. Martindale, cashier. The committee, on procuring a suitable location, reported in favor of securing the store of Thomas Boyle, Kaighn's avenue, above Locust street. They were instructed to procure the same and to make necessary alterations as speedy as possible. Fifty per cent. of the capital stock was paid in at the meeting.

The funeral of George Murphy, the engineer who lost his life so heroically on Saturday morning at the Franklinville collision, will take place at Mount Holly to-morrow morning. Coroner Beale will hold the inquest at eleven o'clock this morning.

The dead body of an infant was found in a clump of willows on Broadway, near Branch street, yesterday afternoon by Police Officer Fox, of the Sixth ward. It was taken in charge by Coroner Davis and afterwards removed to the City Morgue. It is surmised that the child met its death by foul means.

The body of William Knowells, the Englishman who was drowned off Chestnut street wharf about two weeks ago, was recovered yesterday, and taken in charge by Coroner Davis, who ordered it interred immediately, it was so badly decomposed.

Mary Ritz, a German, who lives at Third and Spruce streets, was held in \$500 bail by Justice Davis yesterday for trial, on the charge of larceny as bailee.

Henry Peters, living at Tenth and Chestnut streets, Camden, was terribly bitten about the neck and shoulders yesterday by a vicious horse.

Isaac Rogers, of No. 114 West street, Camden, was seriously injured yesterday afternoon by falling into a pit at the Camden Iron Works.

John Chadwick was charged before Mayor Bradshaw yesterday morning with assault and battery on Frank Reed. He was held to bail in the sum of \$100 for trial.

The delinquent city taxpayers will have their properties sold by the City Solicitor on the 19th instant.

Mrs. William Willis, an aged lady, residing on Spruce street, between Sixth and Seventh, fell down the cellar steps on Sunday night and fractured her arm in three places.

Hamel D. Bergen, ex-solicitor and auditor of the Board of Chosen Freeholders of Camden county, is credited with having caught a 115-pound drum fish recently at Cold Spring Inlet, Cape May.

Burglars at an early hour yesterday morning entered the residence of a farmer named McMaster, on the Chew's Landing road, a short distance from Haddonfield, and succeeded in getting possession of a check for \$1000 and \$150 in cash. They were discovered as they were leaving the premises and fired at, but they managed to escape.

Burglars made an unsuccessful attempt yesterday morning to rob the store of P. W. Taylor, at Haddonfield.

The citizens of Haddonfield are terribly alarmed at the numerous robberies in that borough of late. Should a thief be caught in the act no doubt judge Lynch will be appealed to.

The pond at Blackwoodtown, which supplies the Almshouse with water, has been in a bad state of late, and the committee decided a day or two since to draw off the water, fearing an epidemic. When this was done about 5000 dead fish were found at the bottom. The supply will now be obtained from the asylum, until a dam can be placed in the stream close at hand, where a pure supply will be obtained.
