

# KAIRER'S MURDERER IN THE CAMDEN JAIL

**Arrest of Two Men Who Heard  
Theodore Lambert Say He  
Had Killed the Baker.**

**Stolen Goods Found in the House Where  
the Confession Was Made.**

**The Revolver With Which the Crime  
Was Committed Identified—Evi-  
dence That Will Clear Up the  
Mystery and Win a Reward for the  
Detectives.**

The Camden police authorities last night claimed to have positive evidence that Theodore Lambert, who is locked up in the county jail, is the man that murdered Baker William G. Kairer in the parlor of his residence, at Fourth and Beckett streets, Camden, in the early dawn of the 4th of December last.

Detectives Alexander and McKenty yesterday arrested in this city two colored men, George Greenleaf, of 1883 South Ninth street, Camden, and Josiah Stevens, of 1011 Locust street, this city. The prisoners were taken to the Central Station and said that on the morning of the murder, together with four other colored men, they were at 1883 South Ninth street, Camden, when Theodore Lambert came in.

#### **Lambert Said He Did It.**

He showed them Baker Kairer's gold watch and the revolver with which he said the crime had been committed. It was a self-cocking, 32-calibre weapon, and he gave it to one of them to pawn.

Chief of Detectives Miller showed the prisoners a revolver which they identified as the one Lambert had.

The prisoners were taken to Camden and held as witnesses, but afterwards were released on their own recognizance.

Assistant Prosecutor Ridgway, County Detective Gallagher and Police Lieutenant Smith, of Camden, accompanied by Detectives Alexander and McKenty, of this city, went to 1881 and 1883 South Ninth street, Camden, last night and arrested Richard Martin, Daniel, alias "Dick" Sampson, Joseph Leonard and Lavina Moore as witness.

#### **Stolen Goods Found.**

They also discovered a miscellaneous collection of stolen goods, consisting of silver nut picks, butter knives, fruit knives, butter dishes, knives and forks, spoons, lace curtains and linen. The lace curtains were found in Lambert's trunk. This is the plunder from numerous robberies in Camden during the past year which Lambert confessed.

Theodore Lambert was arrested on the day of the murder on suspicion of committing the crime and he has since been locked up in the Camden County Jail.

Lambert when arrested said that William, alias "Blackstrap" Davis, was with him at the time Kairer was shot. On this information Davis was arrested in New York and taken to Camden last week on requisition papers.

The police authorities refused to state last night whether they had any evidence that would connect him with the crime.

The rewards for the arrest and conviction of Baker Kairer's murderer amount to \$1000.
