

# GETS SAME SENTENCE AS PARTNER IN CRIME

## Judge Boyle, in Camden Common Pleas Court, Deals Out Justice to Several Offenders

Convicted of participating in the robbery of the storehouse of the Pennsylvania Railroad at Delair, John Clemento was yesterday sentenced to State Prison by Judge Boyle in the Camden Criminal Court for a term not less than eighteen months nor more than three years. His conviction resulted principally through the testimony of Joseph Romano, his partner, who is now serving a similar sentence in State Prison.

Charles and Lewis Azedi, convicted of stealing brass from a Merchantville shop, were sent to the State Reformatory and the State Home for Boys respectively. John Breidenbach and Samuel Dobbins, who stole coal from William J. Cooper's yard, were sent to the Rahway Reformatory. Antonio Morganzi, implicated in a Black Hand affair among Italians employed at the coke works, was fined \$100 and sentenced to a month in jail on a charge of obtaining money under false pretences. For cutting his wife in the back, John Scott was given six months.

The family had been away and the intruders had an excellent opportunity of ransacking the place after they had forced a rear window and left the back door open in readiness for a hasty retreat if discovered. They secured a diamond ring, two gold watches and chains, a diamond stickpin, two bracelets and \$40 in money.

### Sends Trio to Jail

"You have caused enough trouble in this world and it is a wonder you don't behave yourself," said Recorder Stackhouse in the Camden Police Court yesterday, addressing Mrs. Frances Wienefski, a member of the boathouse colony at the foot of Viola street. She had been arrested by Policeman Gondolf with Joseph Wachiski and Stanley Rubinski, who were fighting over her. She has been in the Police Court at various times since. Recorder Stackhouse sent the trio to jail for twenty days.

### Hurt in Peculiar Manner

Literally covered with blood, Francis Huston, aged 32 years, of 132 Cedar avenue, Oaklyn, was taken to Cooper Hospital, Camden, early yesterday in a semi-conscious condition. He had been taken from a trolley car. He had a gash across his forehead which bared the frontal bone. After regaining consciousness he stated that he was walking from the kitchen to the dining room at his home when he tripped and fell against a large nail that protruded from the wall.

### Sleepwalker Falls to Death

Walking in her sleep, Mrs. Annie M. Barry, aged 65 years, of 811 Carpenter street, Camden, fell downstairs to her death early yesterday morning. Members of her family were awakened by hearing her moving about but before they could get to her she had plunged down the stairway to the bottom. Coroner Bushey said her death was due to a fractured skull and gave a certificate accordingly.

### Rule Issued in Nursery Fight

As an echo of the factional fight between those interested in the Mary J. Ball Home and Day Nursery, Vice Chancellor Leaming, in Camden, yesterday granted a rule to show cause why the action of the Board of Trustees in dissolving the corporation and giving the property to Dr. Emma Richardson should not be set aside. The application was made by counsel for the Lady Board of Managers. The rule was made returnable next Monday.

Five Chinamen accused of being in this country without proper certificates were committed to jail by United States Commissioner Johnie in Camden yesterday. All have laundries in various parts of Camden. Immigration Inspector Charles V. Mallet, who is conducting a crusade against Chinamen who have not proper credentials, made the complaint.
