

ENTERED U. S. DISGUISED AS WORKMEN, THEY SAY

Arrest of Two Italians in Camden May Disclose Scheme to Smug- gle Undesirables Into Country

In the arrest of Antonio Bruno, aged 20 years, and Adolfo Dangelo, aged 19 years, of 343 Sycamore street, Camden, by Detective Troncone, the United States immigration authorities believe there has been many undesirables permitted to enter this country over the Canadian border line. The two Italians were yesterday sent to the Gloucester Immigration Station pending further action with probable deportation while the government through Immigration Officer E. D. Phillips, has begun an investigation as to conditions along the dividing line between this country and Canada.

It was through chance that Detective Troncone gleaned information to arrest the two youths. He was at Fourth and Pine streets, Camden, when he overheard them talking about getting into this country and when he later went to their home on Sycamore street they were subjected to an examination and their arrest followed.

According to information given by them they had tried to get into this country through one of the ports of entry, but had been refused admission because of physical disability. Then they were told that if they would go to Canada they would be able to enter this country. The two aver they saw an influential Italian at Niagara Falls on the Canadian side and that he promised to get them across for \$25. This was decreased to \$12. Then they were disguised as workmen and succeeded in crossing, later coming to this section.

Arrested for Desertion

Although he has a wife and six children, William Burns, aged 33 years, of 3057 Janney street, Philadelphia, was arrested at 308 Benson street, Camden, by Detectives Moffett and Murray on a charge of desertion, and Recorder Stackhouse held him pending requisition papers.

Grammar School Pupils Graduated

More than one hundred pupils from the various grammar schools have been graduated into the Camden High School and crowded conditions has placed the Board of Education in a quandary as to how to provide for the new students. The Board of Education had provided for a bond issue of \$412,000 to erect a new building, but the Supreme Court decided this course unconstitutional.

Must Pay for Cow's Damages

Because the cows on the farm of Thomas McMichael, a wealthy farmer at Stratford, N. J., wandered into the truck patches of Harry Horay, John Barefott and John Menn, McMichael must pay them \$500. McMichael agreed to reimburse his three neighbors, but a satisfactory arrangement could not be made and the matter was taken to court. A judgment of \$600 was given and an appeal made before Judge French in the Camden District Court. He refused a new trial, but cut the judgment down to \$500.

Will Not Tell Who Stabbed Him

With a severe stab wound of the left side, George Kelly, aged 37 years, of 1523 Rodman street, Philadelphia, walked into the Homeopathic Hospital, Camden, yesterday for treatment. The wound bled profusely and was declared serious, but Kelly refused to throw any light on the matter further than to say, "Me and a friend had a tilt."

Charged With Stealing Gifts

His regard apparently cooling, Louis Kratch, of Philadelphia, is alleged to have gotten back presents he had given Miss Rose Kripitz, of 512 South Fourth street, Camden, and as a result the young man was yesterday held in \$300 bail by Justice Huyett on a charge of obtaining the articles by false pretense. Miss Kripitz alleges that while the defendant called on her he gave her a gold bracelet and a diamond. On January 16 last he asked for the bracelet with the understanding he was to get the young woman's initials engraved, and later secured possession of the diamond to have it reset. Then he is alleged to have ceased his calls.

Wants Help Aiding Poor

So affected was former State Assessor David Baird by the distress brought to his attention through his work as president of the Camden Citizens' Relief Association, that during the past week he asked all the officers to give their personal attention toward raising the fund to the \$3000 mark. He apparently got to work immediately, for yesterday he turned over to the fund \$520, bringing the total up to \$2000. Mr. Baird has been at the relief headquarters every day and has not only given cash and assistance in other ways, but has interested many in the work so that the task of looking after the unfortunates will be considerably lightened. Officials of the Victor Talking Machine Company subscribed \$200.

Bride of a Night Wants Divorce

Avowing that she was deserted by her husband the night of their marriage, Mrs. Mattie Lee Hunt, of Fourth and Berkley streets, yesterday began suit in the Chancery Court in Camden for a divorce. She asserts that on May 18, 1912, she went to Wilmington with Harry Hunt, where they were married by Rev. N. C. Lassiter. The same night, it is alleged, Hunt disappeared and she returned to the home of her parents. He is said to have been last heard of in Indianapolis.

Two Attempt Suicide

Two persons attempted suicide on the streets of Camden last night, but were unsuccessful. They will recover Frank Danker, 34 years old, of Hammonton, despondent because he was out of work, drank a quantity of ether at Market and Fourth streets. He was rushed to Cooper Hospital. Mrs. Agnes Dean, 27 years old, of 237 Kaubn avenue, who said she had a quarrel with her husband, drank a quantity of laudanum and was sent to the Homeopathic Hospital.
