

LONG LIST OF OFFENDERS.

TWENTY-EIGHT PEOPLE WERE ARRAIGNED AT CITY HALL.

Several Men Charged With Highway Robbery—Juster Held for a Fur- ther Hearing on Account of Fast Driving.

The number of prisoners arraigned before Magistrate Pole at the Central Station yesterday almost equaled that of May 15, when thirty-three defendants were given a hearing. Twenty-eight faced the magistrate yesterday, three of whom were women. Among the number were William F. Buchanan, of 1221 Knight street, Camden, and John Emerick, of 714 Race street, who are accused of drugging and robbing Henry M. Pye, a traveling salesman, of 232 North Fifth street, on Friday morning last. Pye testified that he first met Buchanan and afterwards Emerick. He was robbed of \$250. Buchanan denied that he put chloral in Pye's liquor. They were held in \$2000 bail for trial.

Edward Carr, of the rear of 908 North Delaware avenue, was committed on the charge of highway robbery. The complainant, Simon Martins, a German immigrant, testified that while he was walking along Beach street early yesterday morning Carr and three other men approached him and while the others held him Carr stole his watch. Carr was captured by Officer Snyder.

William McKeegan, of 912 Fitzwater street, charged with being one of the three men who assaulted and robbed Edward Crosby, of 731 South Ninth street, on March 11, was committed for a further hearing.

Officer Thomas W. Miller, of the Fifth district, who was arrested for the alleged theft of a watch belonging to Mrs. Brinton from the Aldine Hotel during the fire on May 15, was placed under \$800 bail to appear at the present term of court.

WITNESSES UNABLE TO APPEAR.

William Juster, the young student, of 1010 Spruce street, charged with running over and injuring Mrs. Isabella Bacon and her two sisters, Misses Sallie and Lizzie Givens, of Wilmington, at Eighth and Arch streets on Wednesday last, was held in \$1000 bail for a further hearing on May 20. The attending physician says that the ladies are out of danger and will probably be able to appear against the accused at the next hearing.

Charged with stealing jewelry and clothing worth \$125 from her employer, Mrs. Emily Eily, of 1416 Arch street, Sadie Anderson, colored, of 509 South Thirteenth street, was held in \$1000 bail.

Frederick Klein was bound over for the alleged theft of a gold watch and chain from John A. T. Irvin, of 712 North Twenty-third street. Irvin, it is said, was drugged before he was robbed. John Sullivan and Joseph Mahan, who were in Klein's company when he attempted to pawn the watch, were sent to the House of Correction for nine months.

Calvin Wallace, colored, of 2013 Siegel street, was held for trial charged with enticing the 13-year-old daughter of Matilda Walker away from home for immoral purposes.

A SPEAK-EASY CASE.

Thomas Shea, of 1328 North Tenth street, was held in \$1200 bail charged with keeping a speak-easy. Philip Shea, a son of the accused, was placed under \$600 bail on the charge of threatening to kill Edward Doyle, of Heath street below Girard avenue, who caused the elder Shea's arrest.

John Willis, of Broad street near the League Island Navy Yard, was held in \$600 bail to answer the charge of selling diseased meat.

For the alleged theft of a watch and a pocketbook containing \$2 from the house of Sarah Gaines, 822 Montcalm street, John Tolliver, colored, was held for trial.

Mary Forbes, of 318 Dugan street, was held to answer for the alleged theft of \$96 from the house of John Diggon, 3642 North Broad street, where she was employed as a servant.

Mamie Rockaway, colored, of 3429 Emerald street, was placed under \$1500 bail for a further hearing, charged with stabbing Antonio Gelamardino, at Lisbon and Hirst streets on April 15.
