

# NEWS OF A DAY IN CITY OF CAMDEN

The body of William Weitzman, aged nine years, of Louis and Chestnut streets, who was drowned in Cooper Creek Monday, was recovered last night.

George Strain, aged 28 years, of 936 Cherry street, who was killed by a train Friday, was buried yesterday.

Dressed in the height of style, Mabel Andrews, aged 16 years, daughter of Mr. and Mrs. Daniel Andrews, of Beach Haven, N. J., was arrested as she stepped from a train at the Pennsylvania Railroad terminal in Camden last night by Detective Hart. Mabel was on her way to see the sights of the city. She is being held as a runaway.

Harry Pfeiffer, aged 33 years, of 823 Mt. Vernon street, Camden, was terribly scalded by the bursting of a steam pipe at the Farr & Bailey Oil Cloth Works yesterday. Pfeiffer was working near the pipe at the time. Enveloped in clouds of the scalding vapor the man was discovered by fellow-workmen as he writhed on the floor in agony. He was taken to the Cooper Hospital, where his body, arms and legs were found to be parboiled. His condition is serious.

Camdenites will go back to the dirty Delaware River water for thirty hours probably next Sunday, when connections will be made with the new thirty-inch water main from Morris Station. Residents of Camden have been enjoying pure artesian water for several years now, since which time typhoid fever is almost unknown, and they do not take kindly to this action on the part of the authorities, which will make them run the risk of imbibing all sorts of disease germs.

Many raids are scheduled to take place in

Camden unless keepers of disorderly houses and gambling dens, who have been notified, do not leave the city at once. An investigation by the police reveals the fact that certain sections of the city are honeycombed with disreputable houses. Mayor Ellis has issued orders for the inmates to get out or be prosecuted.

The Camden police were yesterday asked to locate Mrs. Elsa Pawlinski, of 1004 Broadway, who disappeared Saturday while on a trip to Willow Grove with her husband. She became separated from him, and since he has neither seen or heard from her. They recently moved to Camden from Norfolk, Va.

In default of \$1000 bail each Arthur Sweeten, aged 18 years; Harold Sullivan, aged 15 years; Jesse Seybold, aged 16 years, and Elwood Rogers, aged 18 years, were committed to the county jail in Camden yesterday by Recorder Stackhouse on a charge of being the assailants of Mary Ayres, aged 17 years, of 764 Walnut street, who was attacked and dragged into an alley at Seventh and Walnut streets early Sunday morning. According to the girl she was bodily carried up the alley, where she was found by Policeman Ellis, who was attracted by her cries for help. The boys deny the charge.

Trouble has been evaded at the Camden county jail by the jailors removing Baron Rosenbaum to a separate cell. Rosenbaum, who is accused of embezzling \$6500 from Miss Abbie Doughton, was placed in the large temporary cell room with about sixty other prisoners. His fastidiousness aroused the ire of his fellow-unfortunates, especially when he insisted on having a daily bath. He also paid a negro ten cents to wash his feet. The matter was brought to a climax yesterday when the jailors discovered him having a pitched battle with several prisoners. Jailors separated the belligerents.
