

## POLITICS IN JERSEY.

**The Bolting Sheriff's Convention Meets at Merchantville—Party Matters Mixed.**

The second convention, or what will hereafter be known as "Daubmann's Bolters' Sheriff Convention," was held at Merchantville yesterday. The famous twenty-five delegates, who stood for the ex-Sheriff for seventy consecutive ballots on last Thursday, at the regular convention, were present, so were delegates from the Third and Fifth wards and Waterford. The latter were the seven men who were defeated in a contest at the regular convention. Charles H. Fowler, of Gloucester City, and Charles P. Fackler, of the Fourth ward, Camden, were made permanent chairman and secretary respectively. The whole thirty-two delegates voted for Mr. Daubmann, and he was, therefore, declared the nominee of the convention.

Independent candidates for Coroner were nominated as follows; First district, Dr. Willie Hunt; Second district, Charles Pedigree, of Stockton township, was chosen by the bolters on the eighth ballot over Dr. Stanton, the regular nominee. Third district, William O. Sloan.

Both tickets as completed to date are as follows: Regular Republican ticket: For Senator—Richard N. Herring. Sheriff—David Burd. Surrogate—George E. West. Coroners—First district, Samuel Izard; Second district, Dr. J. G. Stanton. Third district, Hon. H. M. Jewett.

The "kickers," "bolters" and anti Sewell ticket will be as follows: Senator—Edward Dudley. Sheriff—Jacob O. Daubmann. Surrogate—George West, the regular Republican nominee. Coroners—First district, Dr. Willie Hunt; Second district, Charles Pedigree, Third district, William O. Sloan.

The Republicans of Camden county met last night in their respective wards, townships and boroughs, and named delegates to be elected to attend the Legislative conventions. Captain Adam C. Smith says he is in the fight in the First Assembly district to stay. Major F. C. Woolman and Captain W. B. E. Miller are also candidates. In the Second district the contestants for the nominations are John Harris, David C. Yarnots and Assemblyman Young.

Mr. Edward Dudley, who was nominated by the bolting Senatorial delegates, yesterday sent a half-column letter of acceptance to B. L. Donsall, John D. Glover and Peter Arrison, the committee appointed by little "Tommy" Harnard's convention to notify him that he was the choice of the bolters.

### The Legal Executive Committee.

Messrs. Chew and Spangler, the respective chairmen of the Senatorial and Surrogate Conventions, met yesterday morning in accordance with the party rules, and appointed the new Republican County Executive Committee for the ensuing year. Mr. Robinson, chairman of the Surrogate's Convention, was not present. The committee consists as follows.

### Political Pointers.

John Harris will undoubtedly be the Republican candidate for the Legislature in the Second district.

Harry B. Paul, of the First ward, wants the Democratic nomination for Sheriff.

Hon. George Pfeiffer leads the Democrats for the nomination of Senator. David M. Chambers is also mentioned.

The friends of Mr. Dudley announced yesterday his intention of remaining in the field for Senator, although he is reported as offering to compromise on the basis that he is to be made the candidate for Senator and Mr. Burd for Sheriff, giving Mr. Herring the Assembly nomination in the Third district.

Chairman Heber Robinson, of the Surrogate's Convention; Thomas Harnard, chairman of the "bolting" Senatorial Convention, and Charles P. Fowler, who presided at the "Daubmann bolting" Convention yesterday, it is said, are going to form another Executive Committee. Hence two tickets and two Executive Committees.

### Jottings.

The dead body of an infant was found near the Timber Creek bridge, on the West Jersey Railroad, yesterday. It is believed that the babe was thrown from a window of a passing car. County Physician Gross will make an investigation.

The Board of Education of Camden held an adjourned meeting last night. Nothing of importance was transacted.

The Co-operative Association of Camden has elected these officers: President—George W. Tenner. Treasurer—Benjamin M. Brake. Directors—John H. Doerr, David Jones, L. L. Sheppard, H. C. Hopper, A. J. Hoey and Frank Warren.

The following sentences were imposed in the Camden Criminal Court yesterday: John O'Hara, larceny, fined \$5, Raymond Mills, assault and battery, two years in the penitentiary; Charles Mead, breaking and entering five years.

In the case of Burk vs. Sea Isle City Improvement Company, before Vice-Chancellor B. P., in Camden, yesterday, the Chancellor refused to appoint a receiver or grant an injunction. C. K. Landis, the president, made answer, presenting a list of liabilities and assets, showing the company not only to be solvent, but in a highly prosperous condition.

Judge Pancoast, counsel of Burk, alleged the sum of \$15,000 due Mr. Landis was largely for salary, and asked for time to acquire items of said account and to present affidavits. The Chancellor granted two weeks for this purpose. Mr. Landis states that none of the officers get any salary.

Mr. Burk is the owner of \$1000 worth of stock out of \$100,000. No creditors or other stockholders have joined him in the proceedings.
